## REPORTS

Mayor Elaine Wyatt met with APTN and conducted an interview with Roxanne Livingstone. Focus was on the River Road and the proposed traffic route for the mining company Western Copper. It was noted that this access route, was in serious need of repair and is constantly being maintained for local traffic.

Mayor Wyatt also had an interview with CBC Radio stating the same facts regarding the deplorable state of the proposed traffic route being River Road. Chuck Tobin from the Whitehorse star, also received an interview. A comment had been made from the Assistant Deputy Minister that the bypass route was not off the table, and Mayor Wyatt wondered why this Mayor and council hadn't been notified prior to reading it in the news. Mayor Wyatt attending a YRRT meeting and items being discussed were involving a hire, to sustain the group.

Mayor Wyatt met with resident J. DiFruscia regarding the Sewer system and his property.

A meeting with Castle Rock was also conducted, regarding River Road in which it will be torn up, and the new Sewer lines will be inserted along this route.

Tender for the treatment plan was due at the end of August, but this will be delayed as the tendering of the foundation will need to be made first.

Councillor Hansen was happy to have had a joint Council meeting covering some important issues.

Next meeting is scheduled for October 8, 2008 at 5:00 PM.

Councillor Wheeler had questions asked about the Village of Carmacks purchasing land for future land development. It was stated that the Village of Carmacks doesn't have it in their mandate to conduct this kind of business.

Councillor Bodie has sent out emails, to inquire information regarding Meth Labs. He is still waiting for a response.

Councillor Bodie has been in contact with Drug and Alcohol services and hopes to have a meeting possibly in the next month or two.

CAO Bellmore added additional comments on her report regarding the road work and sewage lines. It was mentioned that signage and notices should be placed around the community informing them of road closures and detours during the construction of this project.

Councillor Bodie commented on how nice the boardwalk is starting to look. A proposal for funding for this project was submitted to CDF.
