1. John Laughlin

John let council know that he had been asked to fly to Yellowknife to accept the Commanding Officer Commendation Award. John showed the award to council and let council know he believes this award belongs to the whole community. John told council that the winter carnival event the Jr. Rangers hosted in Carmacks last winter was recognized across Canada.

John let council know that the Jr. Rangers plan on having the same carnival take place in Carmacks again this winter and all the communities will send their Jr. Rangers.

Laughlin told council he has contacted Minister Istchenko and will be drafting a letter to send out to all the MLA's so they can be involved in the carnival as well. John finished his report by inviting Mayor and Council to attend the Remembrance Day ceremony held in Carmacks at the Recreation Centre starting at 1030am Nov. 11. Council thanked John for all his hard work put into the Jr. Ranger program in Carmacks.

2. Kirsti Muller

Kirsti started off her report letting council know that she had been busy all day searching for info on the sewer lateral project.

Bellmore presented council with a written report and broke it down verbally to get them caught up on the events.(Report attached in agenda package)

Kirsti explained that after looking through this project there are two more situations where 1 pipe in someone's line has cracks and another one has roots growing through it. Kirsti explained that since the project was started with Laura Prentices and then Rick Kent was put in at the end of the job that there is a lot of information to look through and discuss.

Kirsti asked council if they were aware of any deficiencies from the project. Bellmore responded that it was an YG project and we were not really informed.
