CAO T. Thomas mentioned that she will be attending a Cannabis workshop in Whitehorse next week and that the FOXY program is a good idea.

Staff Sargent B. Kaeding said that YTG has sent out RCMP members for training, i.e. road side testing, taking blood samples.

Councilor Activity Reports

Councilor Belanger let council know that she attended a marijuana teleconference on September 18th. She thinks that we should have a meeting with the community to clarify who can sell it and where CAO T. Thomas recommended that we need more information about facilitating cannabis. Councilor Belanger let council know that she had a meeting with AYC – Yukon housing. We have a lack on housing in the community.

There are 3 teachers in First Nations housing and are not entitled to staff housing.

The nurses live in staff housing and their rent is subsidized and we need to look into our rental agreements.

Councilor Unterschute asked if the YTG teachers have subsidized rent?

Councilor Unterschute had nothing to report to council.

Councilor Wheeler spent a week in Nova Scotia at the FCM meeting. She was empowered to explain the issues in the north. It was a beneficial trip and she learned a lot. They also talked about urban indigenous housing. There is a need to help every first nation not one specific first nation. Councilor Wheeler attended a meeting in regards to community safety.

Councilor Wheeler will attend the AYC meeting in Watson Lake this week.

Mayor's Report

Mayor Bodie attended a meeting with the Chamber of Commerce in Carmacks where he discussed updates about the Carmacks Arena, Fire hall and housing.

Councilor Belanger asked if we can make rooms upstairs in the fire hall for short term accommodations.

Mayor Bodie said that we should be mindful of the local businesses. Mayor Bodie lets council know that we don't want to take business away from the locals.

B. Kaeding referred to problems with alcohol/ drugs in the community. There are no major changes. Priorities can stay the same. We've had some good RCMP members the last few years. Minister Streicker dropped in Mayor Bodie's office on September 15th and suggested to write a letter to Caucus to thank them for funding the arena.

Councilor Wheeler mentioned that a community member thanked the Mayor and Council on Facebook for their impact.

Mayor Bodie had an interview with CBC in Whitehorse. They asked him how the weather is in Carmacks. Joseph O'Brien spoke with Mayor Bodie and he let him know that he wants to help make a better community. J. O'Brien mentioned that he is willing to help find a new trail up to Two Tree Hill.

CAO Report

Tracy provided council with written report and broke it down verbally.

Subcontractors for the arena are all from the Yukon and there will be some locals from Carmacks for hire.

Councilor Unterschute gave an opinion for reno on new fire hall. Tracy mentioned that there is a \$2 million price difference for reno compared to a brand new building.

Christmas Holidays will be clarified in November.

Tracy asked about an Appreciation Award for long time staff. She will give some outlines at the next council meeting.

Department Reports

Municipal Maintenance Foreman's Report

Tracy received from Leo a quote for \$22,000 for the rec-centre vent system. Will be looking into Gas Tax funds for this.
